#### THURSDAY, DECEMBER 13:

Email any line-up or seeding info changes before 6:00 p. m.

FRIDAY, DECEMBER 14: Three rounds of championship matches and three rounds of  
consolation matches.

Gym opens 8:00 a. m.  
Groom check and Weigh-ins 7:00 to 8:00 a.m.  
Coach's meeting (For last minute information only) 8:30 a. m.

#### ***NO SEEDING OR LINE-UP CHANGES***

Starting times for all rounds are approximate. Wrestlers must be ready when their match  
is called.

Championship rounds are 2 minutes for each period. Consolation rounds are 1:00, 2:00,  
2:00.

Championship round 1 9:00 a. m. \* **NOTE THIS IS**  
**1 HOUR EARLIER THAN PREVIOUS YEARS!**  
Championship round 2 & consolation round 1 2:00 p. m.  
Championship round 3 & consolation round 2 4:00 p. m.  
Consolation round 3 7:00 p. m.  
Consolation round 4 (64 man brackets only) 8:30 p. m.

SATURDAY, DECEMBER 15: Consolation rounds, championship semi-finals, and  
placing matches. We will use seven mats until the semi-finals. This is a double  
elimination tourney and all wrestlers are guaranteed two matches.

Gym opens 8:00 a. m.  
Weigh-ins 8:00 to 8:30 a. m.  
Consolation round 4 (32 man brackets only) 9:00 a. m.  
Semi-finals and consolation round 5 11:30 a. m.  
Consolation round 6 (consolation semi-finals) 2:30 p. m.  
Consolation round 7 (3rd & 5th places) 4:00 p. m.  
Break 6:00 p. m.  
Finals 7:00 p. m.  
Presentation of awards 8:30 p. m.

## **WEIGHTS**

Friday morning weigh-ins will be at National Federation weight classes (103, 112, etc.).

Saturday morning weigh-ins will be at Federation weights plus one pound (104, 113, etc.).

### **EXCEPTIONS:**

**a) If a school competes on Wednesday, Dec. 12 at scratch weight and also competes on Thursday, Dec. 13 and therefore given a 1 lb. allowance (104, 113, etc.), then a 2 lb. allowance (105, 114, etc.) will be given to all teams for both Fri. and Sat.**

**b) If a school competes on Thursday, Dec. 13 at scratch weight, then a 1 lb. allowance will be given on Fri. and a 2 lb. allowance will be given on Sat.**

**Any team in either of these situations must provide at least 48 hours prior notice (to the tournament director) before the Friday weigh-in. Therefore, the deadline for this notification is Wed. Dec. 12, at 7:00AM. All teams will be notified of this situation no later than this deadline.**

NOTE: The new National weigh-in rules apply: we will be weighing in by teams. Upon registering, you will be assigned a number. This number is the order in which you will be called to weigh-in.

**YOU MUST BRING YOUR PRE\_MATCH WEIGH-IN FORM (PRINTED FROM THE NWCA WEBSITE) TO FRIDAY'S WEIGH-IN. IF YOU DO NOT BRING THIS FORM, YOUR ENTIRE TEAM IS INELIGIBLE.**

Scales will be open for wrestlers to check their weights immediately after, and up to 15 minutes after, the last match of the day for each weight class on Friday.

## **ENTRIES**

One wrestler per each of the fourteen weight classes: 103, 112, 119, 125, 130, 135, 140, 145, 152, 160, 171, 189, 215, 285

## **ENTRY FEE**

1. Returning Coast Classic placers.
2. State placer last year.
3. Section placer last year.
4. Record against acknowledged strong opponents.
